Transportation: EVERY participant must have the travel release document (attached) completed and turned into Mrs. Krinke, Mr. Lowry. Mr. Mosier, Mr. Thurmond. Please see the policies on the travel release form for detailed information. Note that students driving themselves may not have other students in their cars.

Parking: Parking is very difficult and time consuming on the MU campus because so many students are participating. Also, portions of the campus are closed. Please allow plenty of time for parking.

Music: Remember, NO PHOTOCOPIED MUSIC - Every solo/ensemble must have original scores of EACH song for the judge, accompanist, etc. All of the measures must be numbered. Do not wait until the last minute to figure this out. Double check that you have your music in order before you leave Lee's Summit. Once you get to Columbia, it is impossible to deal with music issues... be responsible.

Ensembles: All ensemble members need to communicate a time and place to meet and warm-up. There are very few practice rooms, so you may end up warming-up, tuning, etc. outside, etc. You may NOT warm-up in stairwells, etc on campus. It is very important that you warm up together. Don't try to cut it close by arriving to MU too late. Get there early so you don't feel rushed. There is nothing worse than making your entire ensemble stress out because someone is missing. Remember why you are there: to perform.

Attire: Dress for success- No jeans, etc. Ensembles communicate about what you are wearing.

Performance: Arrive to your performance room at least 10 minutes before your scheduled time. Remember you are being adjudicated from the second you walk into the room until you leave. Do not have a reaction (good or bad) about your performance until you exit the room. Please go and support all of our LSW performers as well as people from other schools. There is a lot you can learn by watching others at State! Keep noise levels down in the hallways.

Ratings: You will receive the judges' comments on Monday at school.

Remember that you are representing LSW at all times, and all school policies are in effect while on the MU campus.


